

## RESOLUTION NO. 017-2022

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS**, in accordance with Section 604 of the County of El Dorado Personnel Rules Resolution #018- 2019 applicable to represented and unrepresented employees, and Section 601 of the El Dorado County Salary and Benefits Resolution #118-2021 applicable to unrepresented employees, the Board of Supervisors shall by Resolution establish the salary for all authorized positions within the County.

**NOW, THEREFORE, BE IT RESOLVED** the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed.

**BE IT FURTHER RESOLVED** that the Board of Supervisors of the County of El Dorado does hereby adopt the revised salary ranges for the classifications as set forth herein, and amends the salary schedule, effective the pay period following adoption.

**BE IT FURTHER RESOLVED** that the Board of Supervisors of the County of El Dorado does hereby further revise the salary ranges for Unrepresented Employees classifications and amends the salary schedule, such that all unrepresented classifications, except for those excluded below, shall receive a 2.0% base wage increase effective the first full pay period of January 2023. The excluded unrepresented classifications are: Chief Administrative Officer, Sheriff/Coroner/Public Administrator, District Attorney, Undersheriff, Public Defender, Alternate Public Defender, Sr. Deputy County Counsel, Deputy County Counsel, Associate County Counsel, Executive Assistant, all Extra-Help (EH) Unit Employees, and all classifications that include one or more allocated positions that are represented by a bargaining unit.
