## RESOLUTION NO.

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, in accordance with Section 202 of the El Dorado County Compensation Administration Resolution #227-84 applicable to represented employees, and Section 501 of the El Dorado County Salary and Benefits Resolution #323-2001 applicable to unrepresented employees, the Board of Supervisors shall by Resolution specify the number and classification of all authorized positions for each department of the County; and

WHEREAS, it is necessary for the Board of Supervisors to approve the job specifications for revised or new classifications, and to adopt the salary ranges and designate the bargaining unit for these classifications; and

**WHEREAS**, Resolution #089-2010 established the authorize Personnel Allocation based on the Fiscal Year 2010-2011 final Budget and has been subsequently amended by action of the Board; and

WHEREAS, the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed; and

WHEREAS, the Transportation Department has recommended the reduction of one (1) Deputy Director of Engineering (filled); and

**WHEREAS**, the Board gives direction to the Director of Human Resources to notify the respective bargaining units and the employees of the proposed deletions, and compute the respective retention points for each employee; and

WHEREAS, the Board directs Human Resources to meet and confer in regard to the impact of the initial layoffs that will become effective upon the thirty (30) day notice, as required by the respective Memoranda of Understanding between the County of El Dorado and the affected labor Organizations; and

**WHEREAS**, the reduction in filled positions in the Transportation Department will be effective on Friday, November 5, 2010,

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of El Dorado County adopt the class specification for the classification, and implement the designated bargaining unit as listed below and that this resolution shall, in accordance with Section 203 of the El Dorado County Compensation Administration Resolution #227-84 for represented employees, and Section 601 of the Salary and Benefits Resolution #323-2001, as amended, for unrepresented employees, establish the salary range for the classification to become effective the first full pay period following adoption of the Board of Supervisors; and

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the El Dorado County Board of Supervisors amends the El Dorado County Salary Schedule as follows as set forth below; and
