The County of El Dorado Planning Commission will hold a public hearing in the Planning Commission Hearing Room, 2850 Fairlane Court, Placerville, CA 95667, or remotely as required depending on the current COVID-19 recommendations, on February 24, 2022, at 8:30 a.m., to consider the following: Amendments to the 2021-2029 Housing Element Update of the County General Plan (Project GPA21-0004). The County prepared a revised addendum to El Dorado County's General Plan EIR, certified in May 2003 (State Clearinghouse Number 2001082030) demonstrating that the analysis in that EIR adequately addresses the potential physical impacts associated with implementation of the proposed project and the proposed project would not trigger any of the conditions described in CEQA Guidelines Section 15162 calling for the preparation of a subsequent EIR or negative declaration.
