

RESOLUTION NO. 090-2009

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

APPROVING THE APPLICANT TO APPLY FOR GRANT FUNDS FROM THE STATE OF CALIFORNIA DEPARTMENT OF PARKS AND RECREATION, OFF-HIGHWAY VEHICLE GRANT FUNDS

WHEREAS, the people of the State of California have enacted the Off-Highway Motor Vehicle Recreation Act of 2003, which provides funds to the State of California and its political subdivisions for Operation and Maintenance, Restoration, Law Enforcement, and Education and Safety for off-highway vehicle recreation; and

WHEREAS, the Off-Highway Motor Vehicle Recreation Division with the California Department of Parks and Recreation has been delegated the responsibility to administer the program; and

WHEREAS, procedures established by the California Department of Parks and Recreation require the Applicant's Governing Body to certify by resolution the approval of the Application to apply for Off-Highway Motor Vehicle Grant funds; and

WIIEREAS, the Project appears on, or is in conformance with this jurisdiction's adopted general or master plan and is compatible with the land use plans for those jurisdictions immediately surrounding the Project;

NOW THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of El Dorado hereby:

- 1. Approves the filing of an Application(s) for an Off-Highway Vehicle Grant or cooperative Agreement; and
- Certifies that this agency understands its legal obligations to the State upon approval of the Grant; and
- 3. Certifies that this agency understands the California Public resources Code requirement that Acquisition and Development Projects be maintained to specific conservation standards; and
- 4. Certifies that the Project will be well-maintained during its useful life; and
- Certifies that this agency will implement the Project with difigence once funds are available and the Applicant has reviewed, understands, and agrees with the Project Agreement; and
- 6. Certifies that this agency will provide the required matching funds; and
- Certifies that the public and adjacent property owners have been notified of this Projects (as applicable); and
- Appoints the Sheriff as agent to conduct all negotiations, requests and so on, which may be necessary for completion of the Project.
