If they are sent outside, they will be drawn out which will be unbearable to those who have lost their homes.
- 4. If our Planning Department is not qualified to do the tasks they were hired for, then it's time for the Board to do something about that rather than reward them with a million dollars that is being taken from Caldor Relief Funds.
