

RESOLUTION NO. 116-2021

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Resolution to Accept Saratoga Way and Wilson Boulevard Into El Dorado County Maintained Mileage System

WHEREAS, the Board of Supervisors of the County of EI Dorado ("Board of Supervisors") has general supervision, management and control of the county highways; and

WHEREAS, Section 941 of the Streets and Highways Code authorizes the Board of Supervisors to accept a road that is necessary for the public convenience into the County Maintained Mileage System; and

WHEREAS, the Board of Supervisors will not accept a road into the County Maintained Mileage System unless the road has been designed and constructed in accordance with County standards; and

WHEREAS, Sunset Tartesso, LLC, an Arizona Limited Liability Company (Developer), has made an Irrevocable Offer of Dedication to the County of EI Dorado for a road right of way via the Large Lot Final Map of Saratoga Estates, as recorded at Book K of Subdivisions at Page 34, which was accepted "subject to improvement for public purposes" by the Board of Supervisors via the same; and

WHEREAS, the Developer has made an Irrevocable Offer of Dedication to the County of El Dorado offering for dedication the road right of way a portion of the property identified as Assessor's Parcel Number 120-703-003-100, which was accepted by the Board of Supervisors on November 10, 2020, via Resolution 167-2020; and

WHEREAS, the Board of Supervisors accepted the road improvements for Saratoga Way and Wilson Boulevard as complete and constructed to County standards on July 28, 2020, and the Board of Supervisors is ready to accept the roads into the County Maintained Mileage System,

NOW, THEREFORE, BE IT RESOLVED that, pursuant to Section 941 of the Streets and Highways Code, the Board of Supervisors hereby accepts into the El Dorado County Maintained Mileage System the following:

Saratoga Way [Constructed as "Saratoga Way (Sta. 9+80.00 to 33+26.00)"] the right of way for which was offered, accepted and recorded in El Dorado County documents Book K of Subdivisions at Page 34; and

Wilson Boulevard [Constructed as "Wilson Boulevard (Sta. 1+00.00 to 25+50.00)"] the right of way for which was offered, accepted and recorded in El Dorado County documents Book K of Subdivisions at Page 34.
