## MEMORANDUM OF UNDERSTANDING #3362 AMENDMENT 1 DRUG MEDI-CAL ORGANIZED DELIVERY SYSTEM COUNTY OF EL DORADO AND KAISER FOUNDATION HEALTH PLAN, INC.

This Amendment to the Drug Medi-Cal Organized Delivery System ("DMC-ODS") Memorandum of Understanding ("MOU") is entered into by and between Kaiser Foundation Health Plan, Inc. (formerly identified as KP Cal, LLC) ("KAISER or KP"), and the County of El Dorado ("County or COUNTY") in order to implement certain provisions of CCR, Title 9, Section 1810.370, Welfare and Institutions Code 14715, and other applicable law. The term of this MOU shall renew automatically unless terminated by either party by giving at least ten (10) days written notice to the other party.

## **RECITALS**

- **A.** WHEREAS, KAISER and COUNTY have entered into an MOU by which KAISER and COUNTY have established roles and responsibilities for screening, referral, coordination and delivery of alcohol and other drug services to applicable Medi-Cal beneficiaries in accordance with MOU 3362, dated April 23, 2019, incorporated herein and made by reference a part hereof; and;
- **B.** WHEREAS, KAISER and COUNTY desire to amend the MOU to allow for automatic term renewal and to update the Administrator responsible for administering the MOU.;

NOW, THEREFORE, in consideration of the mutual promises set forth below, the parties agree as follows:

- 1) All references to KP Cal, LLC and KP throughout the MOU are now substituted with Kaiser Foundation Health Plan, Inc. and KAISER.
- 2) The term of this MOU shall renew automatically unless terminated by either party by giving at least ten (10) days written notice to the other party.
- 3) Section 2.2.3 shall be amended in its entirety to read as follows:
  - 2.2.3. KAISER providers will ensure a substance use, physical, and mental health screening, brief intervention, and referral to treatment services for Members, consistent with DHCS APL 21-014 and any subsequently issued superseding APL, as available.
- 4) Section 9 shall be amended in its entirety to read as follows:
  - 9. **Administrator**: The County Officer or employee with responsibility for administering this MOU is Salina Drennan, Alcohol and Drug Programs Division Manager, Health and Human Services Agency, or successor.

Except as herein amended, all other parts and sections of MOU #3362 shall remain unchanged and in full force and effect.
