Purpose of the Plan

- Update the 2005 Plan to enable the County to continue to apply for Bicycle Transportation Account (BTA) Funds by remaining in compliance with BTA Guidelines
- Since 2005 the County has been awarded \$480,000 in BTA Funds
- \$80,000 in 2005/2006 BTA funds for Class II bike lanes on Green Valley Road from Cameron Park Drive to Pleasant Grove Middle School
- \$400,000 in 2007/2008 BTA funds for Class I bike path between Forni Road and Missouri Flat Road
- DOT submitted an application for \$581,900 in 2010/2011
 BTA Funds for the Northside School Bike Path Project

Purpose of the Plan (continued)

- Provides a blueprint for the development of an "ultimate bicycle transportation system"
- Decided emphasis on bicycle transportation, linking activity centers



Plan Development

The plan represents the efforts of the EDCTC, El Dorado County, the County Bicycle Advisory Committee, the Disabled Community, the EDHCSD, Cameron Park CSD, Parks and Recreation Commission, Trails Advisory Committee, Caltrans, City of Folsom, and SACOG





Funding Need

- The plan will allow the County to apply for Bicycle Transportation Account Funds (\$7.2m Statewide)
- Planning level cost estimate to implement all Tier 1 Projects:

15.6 Miles of Class I Bike Path \$6.24m61.7 Miles of Class II Bike Lanes \$10.8m18.5 Miles of Class III Bike Route \$92,500
