



**RESOLUTION NO.**

**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**Resolution to Accept Silver Springs Parkway Into El Dorado County Maintained Mileage System**

**WHEREAS**, the Board of Supervisors of the County of El Dorado (“Board of Supervisors”) has general supervision, management and control of the county highways; and

**WHEREAS**, Section 941 of the Streets and Highways Code authorizes the Board of Supervisors to accept a road that is necessary for the public convenience into the County Maintained Mileage System; and

**WHEREAS**, the Board of Supervisors will not accept a road into the County Maintained Mileage System unless the road has been designed and constructed in accordance with County standards; and

**WHEREAS**, Silver Springs, LLC, a California Limited Liability Company (Developer), has made an Irrevocable Offer of Dedication to the County of El Dorado for a road right of way via the Large Lot Final Map of Silver Springs, as recorded at Book I of Subdivisions at Page 133, which was accepted “subject to improvement for public purposes” by the Board of Supervisors via the same; and

**WHEREAS**, the Board of Supervisors accepted the road improvements for Silver Springs Parkway Onsite (south segment, between Sta. 149+75 and Sta. 194+14) as complete and constructed to County standards on August 26, 2014, and the Board of Supervisors is ready to accept the north segment of Silver Springs Parkway into the County Maintained Mileage System; and

**WHEREAS**, the Department of Transportation acquired the underlying fee title for Silver Springs Parkway Offsite through the Capital Improvement Program (CIP) Project #36105039/76108; and

**WHEREAS**, the Board of Supervisors accepted the road improvements for Silver Springs Parkway Offsite (south segment, between Sta. 134+90 and 149+75) as complete and constructed to County standards on August 31, 2021, and the Board of Supervisors is ready to accept the south segment of Silver Springs Parkway into the County Maintained Mileage System,

**NOW, THEREFORE, BE IT RESOLVED** that, pursuant to Section 941 of the Streets and Highways Code, the Board of Supervisors hereby accepts into the El Dorado County Maintained Mileage System the following:

Silver Springs Parkway [Constructed as “Silver Springs Parkway (Sta. 134+90 to 194+14)”] the right of way for which was offered, accepted and recorded in El Dorado County document Book I of Subdivisions at Page 133 and through the CIP Project #36105039/76108.
