I have strong feelings about the need for creating opportunities for teaching parenting skills for families who may not have had the best experiences growing up and don't have the tools to be better parents. I think that with an investment in teaching/supporting parents, we will see a decrease in child abuse and at risk youth in our community. This was a driving force behind my work with the Parent Participation Preschool.</b>

I have worked with the Placerville Downtown Association as a small business owner and property owner. I have volunteered with the El Dorado Veteran's Resource Center and Military Family Support Group.</b>			
Why do you seek appointment? <b>My youngest child has recently left our home to begin her studies and I find myself with time on my hands. In April 2021, I began working at the District Attorney's office in Placerville and the work has brought into sharp focus for me the need to reach families before they get into crisis. It reminded me of the goals I had when creating the Parent Participation Preschool and renewed a desire in me to see what could be done about creating resources for parents to develop skills through education and support.</b>
