No wonder many residents left early in disgust over another dog-n-pony show that failed to address their concerns. State Parks is driving this \$17M project, but they didn't even have representation that night!

During last October's Town Hall meeting Lori publicly mocked and censored me, but Sue Taylor who lives in Pollock Pines was allowed to speak on an unrelated subject. Not so coincidentally District #4 Planning Commissioner Andy Nevis was present. Residents Jenny Hassler and Katherine Gallagher were also censored and not allowed to speak on Zoom regarding family properties acquired via eminent domain by State Parks for the Hwy 49 realignment. It was expressed last Thursday that the land wasn't used for the intended purpose therefore the property should be returned to the families.

I was a member of the Stakeholder Committee. It was our recommendation that the historic one-lane bridge would remain and the new bridge would be constructed from where the old mill used to stand extending across the river to Gallagher's Field, but State Parks shot down our common sense recommendation.

The County professes to be committed to Good Governance and Core values. However there is an abysmal lack of transparency or accountability, especially when it comes to lawfully responding to PRAs. Case in point is the refusal of Rafael Martinez to email me the Power Point Presentation made during last week's ~~Bridge~~ Town Hall. It revealed construction of boardwalks annexing trails from Henningson Lotus Park and other properties to the Marshall Gold Discovery Park that would go through the old Sierra Nevada House property recently acquired by Howard Penn. What we were really talking about is the dangerous intent of grant money associated with this Agenda 21 Resolution.

DOT has failed to address the abysmal condition of 1.5 miles of Mt. Murphy Road connecting both sides of the Park. The road used to be [2" solid surface], but it has been destroyed by DOT and replaced with this [fine particulate matter.] Brian Mullins claims [this] is the same materials DOT has used on Mt. Murphy Road for 30+ years that compacts to [this] hard asphalt. That is a lie. Rafael's attitude then became insulting, condescending, and disrespectful. Making matters worse, he outright lied to me, all captured on audio. If I had a kid that spoke to me in such a disrespectful and condescending manner, I'd slap him 10 ways to Sunday.

It is irresponsible to spend \$17M on The Mt. Murphy Bridge-To-Nowhere when the road conditions quickly deteriorate making it impossible to drive more than 5 mph. This is a public safety concern, especially in the event of an evacuation on the main thoroughfare from the Park to Garden Valley. .

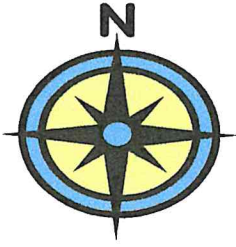

CA Public Records Act Request**

An email response from CA State Parks was received March 26th at approximately 5 PM concerning the above captioned CA Public Records Act (CPRA) request submitted on March 14, 2014. In her response Kelly McDowell stated, *“CSP has no documents responsive to your request, as this project is a county project, not a state project.”*

Contrary to the above statement, Matt Green’s letter to EDC Senior Planner Anne Novotny dated April 4, 2013 justified CSP presence during the Mt. Murphy Road Bridge public meeting held February 7, 2013 at Gold Trail Grange Hall in Coloma. It is also our understanding that CSP will be represented at the Mt. Murphy Road Bridge Stakeholders meeting scheduled to take place April 8, 2014 @ 5:30 – 8 PM at the Coloma Grange Hall.

Additionally Superintendent Jeremy McReynolds was present during the February 4, 2014 Board of Supervisors meeting concerning agenda Item #24 – Mt. Murphy Bridge CIP:

13-0217 Community Development Agency, Transportation Division, recommending the Board consider the following:

- 1) Receive a presentation regarding the feasibility of rehabilitation of the existing Mount Murphy Road at South Fork American River - Bridge Replacement Project, CIP No. 77129; and
- 2) Direct Transportation staff to issue a Notice to Proceed for Phase 1B of AGMT 13-53658 with CH2MHill of Sacramento, CA. (Est. Time: 15 Min.)

FUNDING: Highway Bridge Program (Federal Funds).

On March 11th I addressed the BOS regarding the matter of lawfully complying with the requirements of CPRAs. Subsequently County Counsel made a special CPRA presentation at the March 18th Board of Supervisors meeting, agenda Item #20. During a break I was approached by Assistant CAO Kimberly Kerr in regard to a similar Mt. Murphy Road Bridge CPRA request that was submitted February 25, 2014 to the Board of Supervisors. To date the requested materials have not yet been received. With profuse apologies Ms. Kerr claimed the ‘wording of the CPRA’ relevant to the project caused confusion therefore her personal written response has been indefinitely delayed.

Over the course of the last three years Supervisor Briggs has similarly circumvented related constituent concerns about this CIP. In the interim the county has continued to process input behind closed doors with county staff and other politically influential stakeholders. The unmistakable impression is citizens have been deceptively stonewalled by government bureaucrats meanwhile conducting 'public meetings' with obviously predetermined outcomes utilizing the Delphi Technique.

As you are aware the Mt. Murphy Road Bridge Stakeholders meeting has been rescheduled to take place on April 8th at the Coloma Grange Hall. Note the March 20th reply received from Janet Postlewait to my request for a list of stakeholders, ***"We are beginning the Mt. Murphy Bridge Project in earnest now...Once we have the list of membership, it will be made available to the group at our first meeting - we are still formulating this committee."***

Thus I'm sure you can understand how CSP's obtuse response to this CPRA raises concerns about government transparency and accountability to the residents impacted by the Mt. Murphy Road Bridge CIP and re-routing of Highway 49 according to the 1979 MGDSHP General Plan.

In light of the fact that the Mt. Murphy Road Bridge CIP entails local, state and Federal interests it would stand to reason that CSP must indeed possess documentation relevant to this historic property. Therefore your cooperation is anticipated in responding to the attached CPRAs prior to the April 8th Mt. Murphy Road Bridge Stakeholders meeting and the April 23rd Henningsen-Lotus Park meeting.

The agency must justify the withholding of any record by demonstrating that the record is exempt or that the public interest in confidentiality outweighs the public interest in disclosure. (§6255) If you determine that some but not all of the information is exempt from disclosure and that you intend to withhold it, I ask that you provide a signed notification citing the specific legal authorities on whom you rely.

It is further requested that your determination be made within **10 days, or sooner**, as stipulated within the California Public Records Act, Government Code 6253(c). ***Note these time periods may not be used solely to delay access to the records. (§ 6253(d)) The law makes no provision for extensions due to Covid-19.**

The county has no authority to limit the methods by which they respond to PRAs:

- **The agency may never make records available only in electronic form.** (§ 6253.9(e))
- **Access is immediate** and allowed at all times during business hours. (§ 6253(a)). Staff need not disrupt operations to allow immediate access, but a decision on whether to grant access must be prompt. An agency may not adopt rules that limit the hours records are open for viewing and inspection. (§ 6253(d); 6253.4(b))
- **The agency must provide assistance** by helping to identify records and information relevant to the request and suggesting ways to overcome any practical basis for denying access. (§ 6253.1)
- **The agency must justify the withholding of any record** by demonstrating that the record is exempt or that the public interest in confidentiality outweighs the public interest in disclosure. (§6255)
