

RESOLUTION NO. 073-2022

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, in accordance with Section 602 of the County of El Dorado Personnel Rules Resolution #018-2019 applicable to represented employees, and Section 401 of the El Dorado County Salary and Benefits Resolution #116-2022 applicable to unrepresented employees, the Board of Supervisors shall by Resolution specify the number and classification of all authorized positions for each department of the County.

WHEREAS, Resolution #116-2022 established the authorized Personnel Allocation based on the Fiscal Year 2021-2022 Recommended Budget and has been subsequently amended by action of the Board;

WHEREAS, the Facilities Division of the Chief Administrative Office has recommended the reduction in force of 9.85 full-time equivalent (FTE) Custodian positions (8 filled, 1.85 vacant).

WHEREAS, the Facilities Division of the Chief Administrative Office has recommended the reduction in force of 1.00 full-time equivalent (FTE) Sr. Custodian position (filled).

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed.

BE IT FURTHER RESOLVED, the Board of Supervisors gives direction to the Director of Human Resources to administer the reduction in force process for the Custodian and Sr. Custodian classifications in accordance with the terms of the Letter of Agreement between the County and the affected bargaining unit regarding this reduction in force.

BE IT FURTHER RESOLVED that the Board of Supervisors of the County of El Dorado does hereby amend the Authorized Personnel Allocation Resolution #064-2021 for Sr. Custodian as set forth below, effective Saturday, May 21, 2022.

BE IT FURTHER RESOLVED that the Board of Supervisors of the County of El Dorado does hereby amend the Authorized Personnel Allocation Resolution #064-2021 for Custodian as set forth below, effective Wednesday, July 20, 2022.
