

RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, in accordance with Government Code Section 29007, the Board of Supervisors must approve a schedule establishing the number of allocated positions and salary ranges by classification as part of its adopted budget; and

WHEREAS, in accordance with Section 602 of the County of El Dorado Personnel Rules Resolution #018-2019 applicable to represented employees, and Section 401 of the El Dorado County Salary and Benefits Resolution #116-2022 applicable to unrepresented employees, the Board of Supervisors shall by Resolution specify the number and classification of all authorized positions for each department of the County; and

WHEREAS, Resolution #064-2021 established the authorized Personnel Allocation based on the Fiscal Year 2021-22 Recommended Budget and has been subsequently modified; and

WHEREAS, on May 17, 2022, Resolution 073-2022 was approved by the Board of Supervisors authorizing a reduction in force of 9.85 full-time equivalent (FTE) Custodian allocations (8 filled, 1.85 vacant), and 1.00 full-time equivalent (FTE) Sr. Custodian allocation (filled). The reduction in force will be effective July 20, 2022, amending the FY 2022-23 Authorized Personnel Allocation. Several of the incumbent Custodians elected to remain employed in the classification of Highway Maintenance Worker in the Department of Transportation, requiring a further amendment to the FY 2022-23 Authorized Personnel Allocation; and

WHEREAS, the Letter of Agreement between the County and the affected bargaining unit regarding this reduction in force specifies that the Board of Supervisors shall waive any applicable competitive recruitment, eligibility list, and/or minimum qualification requirements under the County of El Dorado Personnel Rules to facilitate the Highway Maintenance Worker I appointment(s) for affected custodians; and

WHEREAS modifications to the Authorized Personnel Allocation are necessary as a result of the budget process for Fiscal Year 2022-23;

NOW, THEREFORE, BE IT RESOLVED, that allocation changes resulting from the budget process for Fiscal Year 2022-23 are hereby adopted, and amendments to Authorized Personnel Allocation Resolution #064-2021 are hereby incorporated, and the number and classification of all authorized positions in each County department is set forth as shown in Exhibit A, effective July 1, 2022.

BE IT FURTHER RESOLVED, that this Resolution hereby incorporates, by reference, the El Dorado County Salary Schedule effective June 18, 2022 as published on the Human Resources website providing the salary rate or range, as applicable, for all allocated positions.

BE IT FURTHER RESOLVED, the Board of Supervisors hereby waives, and directs the Director of Human Resources to waive, any and all applicable competitive recruitment, eligibility list, and/or minimum qualification requirements under the County of El Dorado Personnel Rules related to the Highway Maintenance Worker I appointment(s) made in accordance with the above-referenced Letter of Agreement.

BE IT FURTHER RESOLVED, the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed.
