

# RESOLUTION NO. 090-2022 OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

## WASTE CONNECTIONS OF CALIFORNIA, INC., dba EL DORADO DISPOSAL SERVICE Material Recovery Facility

WHEREAS, a public hearing was held on June 21, 2022 for the purpose of adjusting the Material Recovery Facility (MRF) collection rates in the Waste Connections of California, Inc., dba, El Dorado Disposal Service; and

WHEREAS, County Ordinance section 8.42.150 provides that the Board of Supervisors shall set the rates to be charged by a franchisee at such time as the Board deems appropriate; and

WHEREAS, pursuant to County Ordinance section 8.42.170, the franchisee has provided written notice to each ratepayer of the proposed adjustment in a form approved by the County of the time, date, and place of the public hearing to set rates and the notice was provided at least ten but no more than sixty days before the public hearing; and

WHEREAS, pursuant to County Ordinance section 8.42.170, notice of the time, place, and purpose of the public hearing has been published in a newspaper of general circulation printed and published in the County, one each week, for two consecutive weeks prior to such hearing.

**NOW**, **THEREFORE**, be it resolved that for the 2022 interim year, effective July 1, 2022, the following rates are adjusted upward according to the fee increases approved by the Board of Supervisors in the Interim Year 2020 to be applied incrementally over three years, as well as by 4.07 percent (4.07%) for the Placerville, CA, Material Recovery Facility gate rates:

## Unsecured Load Fee

\* A fee of twenty-five percent (25%) applied to the rate for the load will be imposed for any load being brought into the MRF without the vehicle being covered to prevent waste or recyclable material from blowing or falling from the load.

## **<u>Recycling Incentive Fee</u>**

\*\* A fee of twenty-five percent (25%) applied to the rate for the load will be imposed for any load of mixed waste that includes recyclable material. Recycling can be dropped off free of charge is segregated prior to entering the facility.
