# The abbreviation GC refers to the General Contractor, their representative or the purchaser of the services and materials specified in this proposal, PS refers to Divide Iron Inc. dba Phillips Steel.

- 1. Proposal pricing is based on price of steel at time of bid. Is subject to change if steel pricing changes, drawings are changed/issued, or addendum(s) issued after date of the proposal.
- 2. Excludes all items not listed and any steel 10 gauge or lighter unless otherwise noted.
- 3. Shop drawings on railings excluded.
- 4. All structural steel provided shop coat primed with Sherwin Williams "Kem Aqua 70P Metal Primer". Except areas requiring field welding or bolted connections that will be cleaned and touched up after completion of such work.
- 5. Bolts supplied for steel to steel connections only, wood to steel bolts supplied by others.
- 6. All embedded steel is FOB installed by others and is the responsibility of GC for layout and to ensure placement matches PS approved shop submittals.
- 7. Unless specified otherwise in this proposal all columns are FOB installed by others. If columns are installed by PS. The GC will set one nut on anchor bolts at each footing or embed point to final elevation.
- 8. PS will install steel to steel & everything else is FOB.
- 9. Job Conditions Unless specified in the bid section of this proposal, the GC is responsible to insure that PS has access to all areas where our work is to be performed. PS is entitled to rely on GC's notice to commence work as representation that the GC has carefully inspected and approved the work performed by others. That all areas are clear and ready for steel installation, that the work surfaces are cleaned, clear and safe for the steel work that it is to receive, align, abut or similarly relate to the work of PS.
- 10. Any work required by PS to provide access make room, clean or safe for prior to commencement work to be completed will be charged as a change order at the field hourly wage rates plus 15%OH and 10% profit..
- 11. If required by contract, GC, or owner a dedicated person for fire protection watch is the responsibility of the GC.
- 12. Excludes deferred approvals unless noted in this proposal.

Phillips Steel will bill 18% per annum service charge for invoices overdue by 30 days or more.

\*\*\*If steel prices increase more than 5% between proposal date and commencement of work at project site a Change Order will be added to Contract.
