To ensure our older adults, especially the frail and vulnerable, have access to services and support that promotes their independence and well-being.

## **OUR CORE VALUES**

**Advocacy:** In that we listen, give voice to, and act to ensure that the needs, desires and concerns of the older adults of the county are understood and respected.

**Advising:** In that we act to ensure that the governing bodies responsible for policy and service delivery organizations responsible for implementation and aligned with the needs, desires, and concerns of older adults.

**Adapting:** In that we are able to pivot when a new or immediate issue may require our focus and attention, while retaining our strategies and plans.

# ACCOMPLISHMENTS

- The COA is an integral part of the AAA and assists in the development and completion of many of the goals and objectives contained within the Area Plan.
- The COA developed and approved new Mission, Vision and Values statements as the first step forward in creating a comprehensive Strategic Plan that will guide the future actions and activities of the commission as a whole and its committees. The Strategic Plan will incorporate new systems for ensuring the sustainability of Commission objectives.
- The COA held its first in-person meetings on February 17, 2022 and March 17, 2022. This is a trend that the COA hopes to continue. Meetings are conducted in various venues throughout the county and are open to the public. Prior to that time all COA meetings were cancelled starting in March 2020. The meetings converted to the virtual platform, Zoom. Commissioners were provided training on the different features and have increased their expertise in virtual meetings. Some of the committees continue to meet via Zoom; others are meeting in-person.
- The **COA** held its annual retreat on February 17, 2022. This retreat was held in person and attended by a majority of the COA Commissioners. We focused on developing the priorities and direction for 2022 and what the new "normal" might entail.

- The COA Commissioner who resides in one of the remote areas, identified the need for increased access to food delivery programs. This Commissioner worked with the Senior Nutrition Program to develop an organizational model to provide the needed home delivered meals. The geography of El Dorado County is rural and contains many very remote and isolated areas. As people age in place, the need for services in the remote areas will increase. This model will be evaluated for appropriateness and implementation in other isolated areas of the county.
- The COA members appointed by the Board of Supervisors are expected to meet regularly with their District Supervisor to share information regarding the needs of their older adult constituents and keep the Board of Supervisors apprised of the COA activities, successes, and challenges. In addition, the COA also provides input to the two incorporated cities within the County: South Lake Tahoe and Placerville.
- The COA and the AAA have provided input to the City of South Lake Tahoe
  on their plans for the proposed new "Multigenerational" facility which will
  incorporate senior services and activities.
- The COA, after a two-year hiatus due to COVID-19, in collaboration with the AAA, reinstated the Senior-of-Year award. There were three awards presented in 2022: Annual Senior-of-the-Year, Lifetime Volunteerism, and Community Strength. The AAA coordinates the press releases announcing the event, application process, and the announcement of the winner by the Chair of the Board of Supervisors. The Commission on Aging reviews the applications, selects the winners, and hosts a reception for all nominees and their families.
- The COA participated in the 2022 El Dorado County Fair at the Health & Human Services Agency booth to meet with older adults and families to advocate for older adult programs.
- The COA members are authoring monthly articles for publication in the Senior Times.

- The COA was honored to elect both a Senator and an Assembly Person
  to the California Senior Legislature which meets annually to propose laws
  to the state legislators and/or members of Congress. Both are members
  of the Rural Caucus and the Senator is on the Transportation Committee.
- The **COA** participates in The Triple-A Council of California to share ideas for programs and advocacy throughout the state.
- The COA regularly welcomes new members with a comprehensive orientation consisting of a printed reference manual and personal tour of the Placerville Senior Center and introductions to the staff of the Area Agency on Aging.
- The **COA** promotes volunteerism for Senior Services programs

Our future will continue the upward spiral of involvement through ideas relating to senior transportation; in-person events; analytics; providing education in technology; the evolution of senior center facilities; and, collaboration with other groups related to older adult issues.
