## NOTICE OF A PUBLIC HEARING

To consider the Resolution Adjusting Bass Lake Hills Specific Plan (BLHSP) Public Facility Financing Plan (PFFP) Fees NOTICE IS HEREBY GIVEN that on August 16, 2022, at 10:00 a.m., or as soon thereafter as the matter can be heard, the County of El Dorado Board of Supervisors will hold a public hearing to receive oral and written testimony regarding the adoption of the proposed resolution revising the area-specific fees, previously set in 2004. The proposed fee will be collected from developers upon the issuance of a building permit within the Plan Area. Interested parties are invited to write their comments in support or opposition to the Resolution to the Board of Supervisors in advance of the hearing. In light of COVID-19, all persons may be required to observe and participate in the hearing remotely as in-person attendance may be restricted depending on the current COVID-19 recommendations as the hearing date approaches.
