Supervisor Thomas you are so adamant about removing homeless from your commercial properties on Main Street/Broadway and to ensure YOUR FAMILY'S property (properties) value go up. You could care less about your District Constituent's properties and the value of their homes or the quality of life for THEIR families.

In fact, Supervisor Thomas, you should recuse yourself from making, participating or using your position to influence a governmental decision, due to the conflict of interest.

To avoid actual bias or the appearance of possible improprieties, per State of California Fair Political Practices Commission, you, Supervisor Thomas, as a public official, are prohibited from participating in this decision.

Supervisor Thomas, based on the Form 700, that you signed under penalty of perjury, you declared:

1. You and your immediate family have a business entity and/or commercial property in which you have an investment of \$2,000 or more, have received income or promised income aggregating to \$500 or more in the previous 12 months, including your community property interest in the income of your spouse (1200-1252 Broadway, 1244 Broadway, 1259 Broadway, 1270 Broadway, 209 Main Street, 359 Main Street).

You are using your position to influence this project, including directing a decision, voting, providing information or a recommendation and/or contacting or appearing before any other agency. When appearing before any other agency, you must not act or purport to act in your official capacity on behalf of the Board of Supervisors or County of El Dorado.

You have a mandated manner, Supervisor Thomas, in which you must disqualify from decisions made at a public meeting (including closed session decisions) and must publicly



identify a conflict of interest and leave the room before the item is discussed.

.....

We can all agree that we need to do something/somewhere - but this is a horrible location for a variety of reasons.

The Navigation Center, a glorified tent, should definitely not go in a residential neighborhood. It will be situated on a one way in/one way out, room for only one vehicle roadway that has access to Weber Creek for “outside of the facility” loitering to occur and contaminate the area with trash and drug paraphernalia.

When two cars are parked on the sides of the road, a vehicle, including emergency vehicles, are unable to pass. Crossing Missouri Flat is impossible during peak traffic times. What homeowner is going to suffer when they widen Perks Court to make room for an expensive, temporary facility?

Who assumes the liability when there are crimes against persons?

Having a “tent” occupy that area for all to see as they are coming into our town is not the image we want for Placerville. In two years, when this project supposedly comes to an end, where are these people going to go? Hangtown Haven dissolved and the homeless stayed and grew, overfilling our streets.

The city currently cannot handle the issues and the Sheriff has stated as such during past meetings. He suggested that a center be built next to the Sheriff facility in order to monitor and control potential issues. This is by far the best option. Why do the most logical options take a back seat? It is a wonderful balance of law and order to protect all and offer the best of services, treatment, and help to our homeless. Knowing what we know about

the percent of chronically homeless and addiction/mental illness, the most human way we can help them is providing all we can in services, but having an understanding that not getting help and doing the work, is not a pass to bringing the problems homeless camps do to our citizens and businesses.

The Navigation Center needs to be placed in a commercial area, not in a residential area.
