The County of El Dorado Planning Commission will hold a public hearing in the Planning Commission Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on September 8, 2022, at 8:30 a.m., to consider the following: Commercial Cannabis Use Permit CCUP21-0001/Embarc Meyers submitted by EMBARC MEYERS, LLC (Agent: Lauren Carpenter) request for a Commercial Cannabis Use Permit for a retail storefront for the sale of cannabis goods for medicinal and adult-use recreational in an existing building. The property, identified by Assessor's Parcel Number 034-671-005 and 034-671-006, consisting of 0.63 acres, is located on the northwest side of US 50, approximately 750 feet northeast of the intersection with Apache Avenue, in the Meyers area, Supervisorial District 5.
