TRANSCRIPT OF OPEN FORUM PRESENTATION MADE BY MELODY LANE TO BOARD OF SUPERVISORS JUNE 22, 2010

Good morning. Melody Lane, Coloma - President of COMPAS, Inc.

I'll be quick and to the point. Ron Briggs, have you ever read Saul Alinsky's "Rules for Radicals?"

By the tactics you've demonstrated, it appears that you have indeed read the Chicago Marxist's infamous book. A primary weapon in the Cold War is *ridicule*. The name of the game is *intimidation* and the goal is to *malign* and eventually burn out civilians who challenge *tyrannical abuses* of governmental power. Obama is a prime example.

Yesterday we learned a new word during the Taxpayers Association meeting. It was associated with the AB 32 forum I attended last month at Union Mine High School.

<u>Factoid</u>: A piece of unverified or inaccurate information that is <u>presented in the press</u> as factual, often as part of <u>a publicity effort</u>, and that is then accepted as true because of frequent repetition. That sure sounds like Adolph Hitler's "Big Lie."

The primary function of *COMPAS* is <u>public safety</u>, <u>transparency and accountability</u>. My focus today is upon RMAC and Environmental Management. I expect that to be properly reflected in the minutes.

For the record, I am the <u>only media contact and authorized spokesperson</u> for <u>COMPAS</u>. My role is meant to ensure the anonymity of members and shield them from **intimidation** or acts of **retaliation** for whistle blowing.

Meanwhile I've taken plenty of "hits" from the River Mafia thugs who've employed the bully tactics outlined in "Rules for Radicals." This was underscored by a personal phone call I received from Congressional candidate Col. Michael Babich when he said, "Melody, it is sad and depressing how dangerous politics has become."

Apparently rogue reporter Chris Daley is another Briggs-Alinsky protégé who is gaining a reputation for unscrupulous journalism. For the record, COMPAS will not associate with him.

Contrary to the deceptively misleading charade spearheaded by County staff at the May 13th RMAC meeting, the Brown Act <u>does indeed address the content of BOS and RMAC minutes</u> ram-rodded through the approval process *without input* from the public:

"The people, in delegating authority, do <u>not</u> give their public servants the right to decide what is good for the people to know and what is <u>not</u> good for them to know...Members of the public have <u>broad</u> <u>constitutional rights</u> to comment on any subject relating to the business of the governmental body."

It stands to reason the public should scrutinize content and comments be accurately reflected. **For the record**, the May 13th RMAC minutes were deceptively written and <u>not</u> publicly posted prior to the June 10th meeting. The fraudulent pattern must stop.

During that meeting I asked about the posting for a replacement of Resident Representative Martin Harris. His notice of resignation was made public in the April 6th edition of the Mtn. Democrat. I've previously entered his letter into the public record along with relevant documents during BOS and RMAC meetings. However Chairman Bill Dietchman feigned total ignorance of Martin Harris' resignation.

Just what's going on here???

<u>Madam Clerk</u>: For the public record, here are copies of Martin Harris' letter to the editor. Included is the revamp of a *COMPAS* news release that was rewritten by a consultant <u>after</u> it was rejected by the Mtn. Democrat publisher. Despite <u>two</u> meetings about the content, Richard Esposito still did *NOT* honor his word to publish our revamped version in a timely manner *prior to the June 8th election*.

Follow the red highlights as I read these incriminating excerpts from Mr. Harris' mocking letter:

I was not party to Ms. Lane's selection to the River Management Advisory Committee or the determination rescinding her selection. I did not know who she was until she started to CC me her email fights with a constituency and ex-friends who apparently thought she was a poor choice as the private boater representative for RMAC. Apparently there were more nays than yeas; otherwise, Mr. John Briggs would not have pulled her appointment.

What the Flamenco Dance folks over at COMPAS did not know was I had already sent in my resignation after the last RMAC meeting.

Mr. Briggs: Apparently the apple doesn't fall far from the tree. Your unscrupulous role in the RMAC scandal should have been evident to the public <u>prior</u> to the June 8th election.

A best selling book I suggest you now read is "How Evil Works" by World Net Daily journalist David Kupelian. It's about an arising Revolution driven by citizens who demand accountability from their elected officials.

El Dorado County citizens are on the march against the destructive forces that have undermined the foundations of our nation.
