RECITALS

WHEREAS, Contractor has been engaged by County to provide continuous transdermal electronic alcohol monitoring equipment, SCRAM CAM Bracelet with and without the house arrest component, SCRAM One-Piece GPS, SCRAM GPS Home Base Cellular unit, and SCRAM Remote Breath, along with access to SCRAM System Program Management Center (currently known as SCRAMNET), and provide necessary equipment and internet based software program training to staff on an "as-requested" basis for the Probation Department in accordance with Agreement for Services #4371, dated January 1, 2019; and its Amendment I, dated May 18, 2021; and its Amendment II, dated January 11, 2022; incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to revise the term of the Agreement, hereby amending **ARTICLE II Term**; and

WHEREAS, the parties hereto have mutually agreed to revise the Compensation for Services of the Agreement, hereby amending **ARTICLE III Compensation for Services**; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #4371 shall be amended a second time as follows:

I. ARTICLE II, Term, of the Agreement is amended in its entirety to read as follows:

ARTICLE II

Term: This Agreement shall become effective upon final execution by both parties hereto and shall cover the period of January 1, 2020, through April 30, 2023.

II. ARTICLE III, Compensation for Services, Paragraph Six of the Agreement is amended to read as follows:

The total amount of this Agreement shall not exceed \$1,600,000.00, inclusive of all costs, taxes, and expenses.
