During the September 27th Open Forum I publicly addressed the inquiry of Kim Dawson regarding staff's request for clarification of my PRA about specific correspondence between directors of the Taxpayers Association, the CAO, and the Board of Supervisors. Instead of responding to me as required by law, Comrade Parlin violated the Brown Act by ordering Ms. Dawson to shut off the mic, called a 5-minute break, and you all stormed out of the room. Apparently David Livingston approved of your tyrannical display because he was the only one who remained seated. Two minutes later you all re-entered the room laughing.

On October 5<sup>th</sup> I received only 3 documents in response to my PRA which had specifically stated that if you intended to withhold any of the information, then the agency must justify the withholding of any record by demonstrating that the record is exempt or that the public interest in confidentiality outweighs the public interest in disclosure, and if you intend to withhold it, I ask that you provide a signed notification citing the specific legal authorities on whom you rely. If the requested records do not exist, then please so state <u>immediately</u>.

In [my October 5<sup>th</sup> reply] to all of you, including to David Livingston and Vern Pierson, I stated that Don Ashton, and Supervisors Turnboo, Novasel and Parlin failed to provide the requested information as required by law, and if you still intended to withhold the information, then please so state immediately. I have not yet received a reply from any of you. It is significant that Todd White, **who is Secretary of the Association and George Turnboo's admin**, was forced to resign two months ago. Todd was just reinstated this week which I understand is today's Closed Session Item #28. This is information the public has a right to know.

Then on October 6<sup>th</sup> when I attempted to send correspondence to the Coloma Lotus Advisory Committee relevant to the meeting at Grange Hall last Thursday night, my correspondence bounced back as undeliverable. I called Kyra Scharfenberg to explain the situation and my concerns that this may be related to **Don Ashton and Sheriff D'Agostini's unlawful** directive to have IT block my ability to correspond with staff. I further explained that may be the reason I'm not getting any responses from Lori Parlin or any department heads. Kyra left me a voice mail on Friday morning that she had conveyed my message and phone number to David Livingston, but all I've heard is the chirping of crickets.

You profess transparency and accountability pursuant to your oaths of office. So if you have no intention to lawfully respond to [this PRA] and provide public services, then let's get it right out there on the public record now while I'm at the podium.

#### CA PUBLIC RECORDS ACT REQUEST

Dear Mr. Carruesco,

Enclosed you will find the most recent affidavit addressed to EDC employee, Todd White. Please be advised that notification of legal responsibility is the first essential of due process of law, and an unrebutted affidavit stands as truth before any court of law in America.

It is significant that prior to retiring I worked for several Capitol legislators, most notably Barbara Alby, the author of California's Megan's Law. I am also a third generation evangelical still actively involved in Capitol ministries. Todd's vulgarity, perpetual discrimination, violations of his oaths of office, and other unlawful conduct described in the enclosed affidavit reflects poorly upon El Dorado County, the Taxpayers Association, Big Brothers/Big Sisters, the Republican Central Committee and Park Community Church where Todd claims to be a deacon.

Todd is a public servant whose salary is paid via my taxes, but it is evident he has no intention of providing me with public services. Supervisor Turnboo is complicit in aiding and abetting Mr. White's unlawful conduct, and since there has been no acknowledgement from staff to take disciplinary action, including termination, then it is reasonable to deduce that the County has taken a position to condone and/or shield Todd from the consequences of his unlawful conduct. Furthermore, it is inconsistent with the EDC Good Governance policy and Core Values of integrity, accountability, and service excellence.

You are aware of the myriad federal and state laws requiring HR to maintain certain records regarding employees. Under SB 807, California law requires that documented complaints, such as this, be investigated and retained in the employee's personnel file for a minimum of four years. In the event of a lawsuit, an employer may be required to produce these records. Failure to do so can lead to fines and other adverse actions.
