I am writing you to request that you do all that you can do to have the CalTrans seismic retrofit project scheduled for the Highway 49 bridge in Coloma include modifications to improve both pedestrian and bicycle safety. I understand money is tight but this is an opportunity that should not be lost. This is not a request for aesthetics but for safety not based on projected future use but based on current use.

The nature of our community is one of summer recreation. Often has visitors staying at campgrounds or lodging on both sides of the bridge. These visitors often to walk to restaurants and bars during the day but especially at night. I'm not sure are trying to avoid drinking and driving or just want some exercise with their night out. The other big pedestrian and bicycle users of the bridge are the seasonal raft guides that make Coloma and Lotus there summer home. The current bridge configuration provides less than half of a sidewalk on each side.

Greetings Supervisor Briggs,

Thank you for your interest and attention to the State Route 49 project. As a resident of the Lotus/Coloma area and a cyclist, I would like to encourage you to speak with Caltrans about incorporating a bicycle/pedestrian route on the bridge that crosses Highway 49 above the South Fork American River. This is a busy stretchespecially in the summertime with locals and tourists congregating in the area. With the wonderful addition of Cronin and Magnolia just north of Lotus, we are seeing a larger number of horse trailers on the road — and as a cyclist, the meeting of the trailers and the trucks that pull them across the narrow 49 bridge is a dangerous and scary proposition. I usually sprint across the bridge because it is such a sketchy stretch of road.

I have often experienced dangerous and aggressive maneuvers and language by my fellow County residents who do not feel that cyclists are as entitled to the roads as their motor vehicles are. Their mirrors have literally come within inches of me as they travel down the road at 30 to 40 miles (plus!) per hour. I assure you, I move over as far to the right as possible when I hear a vehicle approaching. In fact, one such encounter was with a Caltrans utility truck while heading south on highway 49 from Coloma toward Placerville! I can understand motorists frustrations upon encountering a human powered transportation mechanism on our windy roads, but it does not warrant their ensuing aggressive and dangerous behavior.

I think the best solution would be to create enough space for both modes to travel safely at their requisite speed. A ped/cyclist exclusive lane will help mitigate road rage and ensure a safer, more enjoyable experience for everyone who uses our public roads.

In a closer reading of the proposed plan for the Highway 49 retrofit,, I noticed that the proposed narrow lanes and 2.5' wide shoulder do not provide much safety for pedestrians or cyclists. There is no separation railing or a raised ped/bicycle walkway. Considering the congestion at the bridge on summer afternoons, this is a recipe for keeping pedestrians and/or cyclists in harms way of motorists who slow to look at the river, taking their attention away from what is directly in front of them.

Given fiscal constraints, it seems questionable to spend money now on something substandard, only to have to do it all over again later. I would like to see this retrofit address safety as well as seismic concerns.

CLVCA is currently polling 821 valley postal addresses on the desireability of getting pedestrian/bike lanes on our bridge(s). Interim results show that about 25% of residents rank this as one of **the most important** civic improvements of the 38 issues raised in the survey. Other high scoring issues include "Build bike/pedestrian lanes and paths" and "Complete a trail from Greenwood Creek to Coloma".

I am sure that if the question was asked as a stand alone issue, the vast majority of residents would want Caltrans to incorporate pedestrian/bike lanes into the bridge upgrade project.

I also note that the accident reports cited in the Caltrans project proposal seem to have been carefully selected both as to period and distance as to omit car-on-pedestrian accident(s) that have occured in Lotus. And I think it ironic that during construction the contractor must provide a four foot pathway that will not exist when the job is completed.

Caltrans displayed a community-sensitive quality when it put in a safer Hiway 49 segment in Lotus, adding walkways and crosswalks and the blinker at Marshall Road. The Hiway 49 bridge remains as the safety barrier to non-motorized travel in the heart of our community.

Your leadership in working with that agency is greatly appreciated.
