This e-mail is to convey my support of a pedestrian/bicycle friendly solution to the current Highway 49 bridge project in Coloma, currently up for your review. The volume of pedestrian and bicycle traffic this bridge sees makes a solution that considers these users an imperative.

Ponderosa Resort is situated on the North end of the bridge. In 2010, we hosted approximately 58,000 campers, many of whom walk throughout our community frequenting the valley's businesses and parks. Similarly, an irresistable photo opportunity exists for tourists who stand at the railing in the center of the bridge snapping photos of rafters and kayakers passing by on the river underneath.
