## AGREEMENT FOR SERVICES #009-092-P-E2009 AMENDMENT I

This Amendment I to that Agreement for Services #009-092-P-E2009, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as COUNTY) and Barton Healthcare System; (hereinafter referred to as CONTRACTOR).

#### RECITALS

WHEREAS, CONTRACTOR has been engaged by COUNTY to provide specified services in support of the health information exchange (HIE) and Care Pathways development and implementation, in accordance with Agreement for Services #009-092-P-E2009, dated April 27, 2010, incorporated herein and made by reference a part hereof; and

WHEREAS, COUNTY has received an extension of the grant funding through California HealthCare Foundation; and

WHEREAS, the parties hereto have mutually agreed to amended  $Article\ I$  –  $Scope\ of\ Services$ , and

WHEREAS, the parties hereto have mutually agreed to extend the term of the original Agreement, amending *Article II - Term*,

NOW THEREFORE, the parties do hereby agree that Agreement for Services #009-092-P-E2009 shall be amended a first time as follows:

- 1) Article I shall be amended to add to the duties of the CONTRACTOR:
  - (h) Upon final signature of this Amendment I to that Agreement 009-092-P-E2009, the Scope of Services for the remainder of this Agreement shall consist of the following:
    - a. Provide teleconferencing capabilities for ACCEL partners to utilize for Steering Committee meetings, planning sessions, technical workgroup meetings.
    - b. Provide grant writing capabilities to seek additional funding for ACCEL projects.

2) Article II shall be amended in its entirety to read as follows:

### Article II. TERM

This Agreement shall be effective on signature by the parties hereto and shall cover the period September 30, 2009 through June 30, 2011 unless earlier terminated pursuant to the provisions under Article IX herein.

Except as herein amended, all other parts and sections of that Agreement #009-092-P-E2009 shall remain unchanged and in full force and effect.
