Please accept this memo as a weekly update to the activities surrounding the County of El Dorado's recovery from the Caldor & Mosquito Fires as managed by the Recovery Operations Center's (ROC) co-directors Sgt. Moke Auwae and me.

Environmental Management

CALDOR FIRE

- Alternate Program
 - 7255 Winding Way- Waiting on soil sample results EMD received an incomplete set of final documents on 12/7/22. An email was sent with an outline of the deficiencies.
 - o 5221 Butte Creek Road- waiting on soil sample results
 - USPS Parcel is waiting on soil sample results.
 - \circ Deed restriction letter was sent to the above three property owners on 12/9/2022.
 - USFS Parcels
 - o Complete
- Public Program
 - Complete

MOSQUITO FIRE

- EMD compiled a master list of parcels that need to be cleaned and are contacting those that have not submitted an ROE.
- \circ ROE universe = 22
- Permitted Structures:
 - 12 ROEs expected / 9 ROEs received / 8 approved / 1 is incomplete
- Other Structures (unpermitted dwellings & outbuildings):
 - 10 ROEs expected / 5 received / 3 approved / 2 are incomplete
- Vehicles:
 - 34 noted on ROEs / 7 have been requested by owners to be excluded

Land Use

- Fee Waivers 126 received
 - o Temporary Mobile Homes/Temporary Recreational Vehicles
 - 72 Received
 - 90 Approved (even if parcel owners didn't request a TRV/TMH but were eligible for temporary power and demo permit, we included TRV/TMH in the initial approval in case of future need)
- **Rebuild Permits** 61 received
 - o 3 Building Permits Submitted & approved w/ Permit Fees Waived
 - 33 Building Permits Issued w/out Permit Fees Waived
 - o 25 Building Permits Pending w/out Permit Fees Waived
- **TRV Permits** 49 Received
 - o 34 Issued
 - 15 Pending
