FIRST AMENDMENT TO AGREEMENT FOR SERVICES #5758

RECITALS

WHEREAS, Consultant has been engaged by County to provide professional assistance, specifically to the Federal Title IV-E Administrative Claim, to explore opportunities for Federal Financial Participation (hereinafter "FFP"), to review prospects for expansion of existing and new state funding opportunities, and to secure additional FFP as may be appropriate for the Probation Department, in accordance with Agreement for Services #5758, dated July 21, 2021; incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$34,000.00, amending ARTICLE V, Compensation for Services;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this First Amendment to Agreement # 5758 on the following terms and conditions:

I. ARTICLE V, Compensation for Services, Paragraph Four of the Agreement is amended in its entirety to read as follows:

The total amount of this Agreement, as amended, shall not exceed \$134,775.00 inclusive of all costs, taxes, and expenses.

Except as herein amended, all other parts and sections of Agreement for Services #5758 shall remain unchanged and in full force and effect.
