EXECUTIVE SUMMARY

ALL COUNTY LETTER NO. 22-93

The purpose of this All County Letter is to notify county child welfare services agencies of the \$50 million of state general funds appropriated in the State Budget Act of 2022 to enhance child welfare Emergency Response services. This letter provides information on county allocations, allowable funding uses, the county opt-in and opt-out process, and reporting requirements.

SUBJECT: CHILD WELFARE SERVICES EMERGENCY RESPONSE ENHANCEMENT FUNDS FY 2022-23

REFERENCE: <u>SENATE BILL 129 (CHAPTER 69) THE BUDGET ACT OF 2021;</u> ASSEMBLY BILL 179 (CHAPTER 249) THE BUDGET ACT OF 2022; ALL COUNTY LETTER NO. 22-02; COUNTY FISCAL LETTER NO. 21/22-111; COUNTY FISCAL LETTER NO. 21/22-73;

The purpose of this All County Letter (ACL) is to notify county child welfare services (CWS) agencies of the \$50 million of state general funds appropriated in the state Budget Act of 2022 to increase the number of child welfare social workers in Emergency Response (ER) services and enhance existing ER child welfare services. This letter provides information on county allocations, allowable funding uses, the county opt-in and opt-out process, and reporting requirements.

PROGRAM BACKGROUND

<u>The Budget Act of 2021</u> first appropriated \$50 million of state general funds for the purpose of enhancing a county CWS agency's existing ER services, resulting in a net increase of staff for hotline and investigative functions. These funds are available for encumbrance or expenditure until June 30, 2025 (See County Fiscal Letter (CFL) <u>No.</u> 21/22-73 and <u>CFL No. 21/22-111</u>). The <u>CFL No. 21/22-111</u> provides the final allocations for all 58 counties for the FY 2021-22 funding.

<u>The Budget Act of 2022</u> has appropriated an additional \$50 million of state general fund for the same purpose of enhancing a county CWS agency's existing ER services. This additional funding is available for encumbrance or expenditure until June 30, 2026.

The ACL No. <u>22-02</u> provides county CWS agencies with examples of allowable uses for these funds, aimed to increase the number of staff entering and remaining in the ER workforce. The ACL also provides several ways these activities may result in better quality investigations and positive outcomes for children and families.

In ACL No. <u>22-02</u>, county CWS agencies were also asked to opt-in or out of receiving the initial allocation of \$50 million by submitting to the California Department of Social Services (CDSS), the ER Enhancement Funding County Notice Letter (Attachment I). County CWS agencies that opted in were required to develop and submit a plan (Attachment II) to the CDSS that identifies:

- Their specific needs relevant to increasing ER staff and enhancing ER services quality;
- A description of each strategy they will implement that meets the needs of their specific ER programs;
- The method for measuring change;
- The specific outcomes the county expects to see for each strategy; and
- An explanation of how the funding will be spent and what strategies those dollars will impact.

CHILD WELFARE SERVICES ER ENHANCEMENT FUNDS PROGRAM

With the additional allocation of \$50 million in the <u>Budget Act of 2022</u>, the CDSS would like to provide county CWS agencies who did not opt-in to receive the funding in Fiscal Year (FY) 2021-22, the opportunity to opt-in to receiving their allocated amount for FY 2022-23.

Any county may opt-in or opt-out of receiving an allocation of the <u>Budget Act of 2022</u> funding regardless of whether they chose to opt-in or opt-out of receiving an allocation of the <u>Budget Act of 2021</u> funding.

Opt-In Process

Consistent with Fiscal Year (FY) 2021-22 instructions contained in ACL No. <u>22-02</u>, all county CWS agencies that choose to opt-in and receive funding for FY 2022-23 must submit the ER Enhancement Funding County Notice Letter (Attachment I) by March 1, 2023, to <u>childprotection@dss.ca.gov</u>.

Counties who choose to receive funds must also develop and submit a plan (Attachment II) to the CDSS in accordance with the instructions in ACL No. <u>22-02</u>. County CWS agencies that wish to make updates to their initially submitted plan may send in an updated plan using the county plan update template in Attachment III in ACL No. <u>22-02</u>.

Opt-out Process

If a county CWS agency elected to opt-out of FY 2021-22 and wishes to opt-out of receiving funds for FY 2022-23 also, only Attachment I is required.

Annual Updates

Counties that receive funding must include in their annual update how the funding was allocated for each FY. Counties will submit their updated plans annually to CDSS, with the first annual update due on June 30, 2023 for those counties that opted to receive funding in FY 21-22. However, if a county is opting in for the first time in FY 22-23, the due date for the annual update will be June 30, 2024.

Allocation Methodology

Consistent with the FY 2021-22 allocation methodology, and as explained in ACL No. <u>22-02</u>, in consultation with the County Welfare Directors Association, the <u>Budget Act of</u> <u>2022</u> \$50 million of state general funds for the enhancement of child welfare ER services is distributed as follows:

- Fifty percent of the funds are distributed based on counties' total number of referrals and investigations from July 2020 to July 2021, as reported in Safe Measures Reports.
- The remaining 50 percent is distributed based on counties' ER caseload safety and risk data from July 2020 to July 2021, as reported in Child Welfare Services/Case Management System. Specifically, counties with larger, more unsafe, and higher risk ER caseloads are provided a larger allocation of funds.
- The allocation is then adjusted to ensure that each county receives a minimum of \$129,000 based on the estimated cost of funding a full-time equivalent child welfare social worker.

Attachment III displays estimated allocations for all counties if all counties opt-in for the FY 2022-23 funding. A final allocation distribution and claiming instructions will be provided in a forthcoming CFL. The CDSS will redistribute the planning allocation amount of any counties who choose to opt-out to the remaining participating counties.

The purpose of this letter is to inform the California Department of Social Services that El Dorado County elects to: (Choose Option 1 or 2)
