I have just learned that the DOT has put an item regarding Carson Crossing on the Consent Calendar asking you to approve Resolution 041-2023 accepting Carson Crossing Drive into the El Dorado County Maintained Mileage System.

We have hundreds of people in the Latrobe area as well as those of us on the APAC Transportation Committee who are concerned about Carson Crossing and want to be informed about the County's plans.
