FIRST AMENDMENT TO AGREEMENT FOR SERVICES #6910

RECITALS

WHEREAS, Consultant has been engaged by County to perform Project Consultant tasks as written in the El Dorado County Probation Department Behavioral Health Justice Intervention Services (BHJIS) Statement of Work; in accordance with Agreement for Services #6910; dated October 18, 2022; incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date of the term of the Agreement, hereby amending ARTICLE II – Term;

WHEREAS, the parties hereto desire to add language pertaining to the Levine Act, hereby amending ARTICLE XXI – Conflict of Interest;

NOW THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this First Amendment to Agreement #6910 on the following terms and conditions:

I. ARTICLE II, Term, of the Agreement is amended in its entirety to read as follows:

ARTICLE II

Term: This Agreement shall become effective upon final execution by both parties hereto and shall cover the period of February 15, 2022, through March 31, 2024.

II. ARTICLE XXI, Conflict of Interest, last paragraph in the Article is added to read as follows:

Pursuant to Government Code section 84308 (SB 1439, the Levine Act), Consultant shall complete and sign the attached Exhibit B, marked "California Levine Act Statement," incorporated herein and made by reference a part hereof, regarding campaign contributions by Consultant, if any, to any officer of County.

Except as herein amended, all other parts and sections of that Agreement #6910 shall remain unchanged and in full force and effect.

California Levine Act Statement

California Levine Act Statement

California Government Code section 84308, commonly referred to as the "Levine Act," prohibits any officer of El Dorado County from participating in any action related to a contract if he or she receives any political contributions totaling more than two hundred and fifty dollars (\$250) within the previous twelve (12) months, and for twelve (12) months following the date a final decision concerning the contract has been made, from the person or company awarded the contract. It is the Contractor's/Consultant's responsibility to confirm the appropriate "officer" and name the individual(s) in their disclosure.
