#### FIFTH AMENDMENT TO AGREEMENT FOR SERVICES #471-S1211

**THIS FIFTH AMENDMENT** to that Agreement for Services #471-S1211 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and GovernmentJobs.com, Inc., a corporation duly qualified to conduct business in the State of California, doing business NEOGOV, whose principal place of business is 300 Continental Boulevard, Suite 565, El Segundo, California 90245, (hereinafter referred to as "NEOGOV");

#### RECITALS

WHEREAS, NEOGOV has been engaged by County to provide software and related services for the Human Resources Department pursuant to Service Agreement #417-S1211 dated January 25, 2012, First Amendment to Service Agreement #471-S1211, dated March 13, 2018, Second Amendment to Service Agreement #471-S1211, dated August 19, 2019, Third Amendment to Service Agreement #471-S1211, dated June 30, 2020, and Fourth Amendment to Service Agreement #471-S1211, dated June 21, 2021, all incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to update County's Contract Administrator, amending **Section 14**, **Administrator**;

**WHEREAS**, the parties hereto desire to amend the Agreement to update the annual subscription fee for Fiscal Year 2022-2023 to \$72,293.49, and add Addendum V to Exhibit A, Sigma Upgrade Order Form, for the period of July 1, 2022 through June 30, 2023;

**NOW, THEREFORE,** in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and NEOGOV mutually agree to amend the terms of the Agreement in this Fifth Amendment to Service Agreement #471-S1211 on the following terms and conditions:

- I. Section 14, Administrator, of the Agreement is amended in its entirety to read as follows:
  - **14. Administrator:** The County Officer or employee with responsibility for administering this Agreement is Joseph Carruesco, Director, Human Resources Department, or successor.

**II. Exhibit A, Sigma Upgrade Order Form,** of the Agreement is amended to add Addendum V to Exhibit A, for the period of July 1, 2022 through June 30, 2023; all prior Order Forms shall expire and be of no further force or effect as of July 1, 2022.

Except as herein amended, all other parts and sections of Service Agreement #471-S1211 shall remain unchanged and in full force and effect.
