My experience as a homeowner with neighboring VHRs has been less than ideal. Gone are the days when my neighbors rented their house out on the odd weekend. This has been replaced with regular visitors with no association to the owners much less our neighborhood. Every weekend or long holiday results in cars filling the streets, loud parties and total disregard for the neighborhoods subjected to these 'guests'. I have had bus loads dropped off with an actual bus delivering and picking up our 'guests'. I have had my yard trampled upon by visitors thinking every square inch of snow or forest, including that in my yard, is open for their amusement (after all, they are on vacation). My neighborhood is a far from Stateline as is possible and yet here we are.

I'd like to bring to your attention the importance of maintaining the cap on VHR's in the county. It may be considered unnecessary due to the existing 500' buffer between VHR's, however it has substantial importance to the members of this community. We have and still struggle with the proliferation of VHR's and their impact to our community. Removing anything that we have struggled so hard to achieve is met with a tremendous amount of cynicism. We still have unacceptable issues because of these businesses in our neighborhoods. Just this past Sunday alone, my dogs were attacked by a dog from a VHR that ran into my driveway. The visitor had just turned his dog loose to run around the street without even watching him. This could have been serious as all animal hospitals were closed and the roads out of town were frequently closed as well, denying me the opportunity for medical care. In addition, the owner of another VHR on my street showed up and removed all the snow from his roof and dumped it directly onto my neighbors fence and into her backyard. She is 60 years old, lives alone with her dog and now can't let her dog into her own yard because her dog can walk right over the fence. This behavior is unacceptable and needs to be addressed. The storms that we have had are difficult without the interference of people unaccustomed to our neighborhood environment. The companies that perform snow removal at the VHR's are coming in the middle of the night and showering our windows with chunks of ice and snow, waking our entire house. I called the companies and was told

because I am not their customer, they don't care what I have to say. 30 years in my home and I have never had these types of problems with my neighbors, only the VHR businesses. The previous description it just a normal day living with these motels in our neighborhoods. Please don't go backwards, let's move forward to protect our dwindling community.
