Agricultural Commission Appointment for January 11, 2011 Board Meeting

In accordance with Agricultural Commission Bylaws adopted by the Board of Supervisors on August 31, 2004, a Notice of Terms of Office Expiration was submitted to the local newspapers and to county agricultural organizations. In addition, an independent Review Panel comprised of industry representatives as specified in the Agricultural Commission By-Laws § 4(a), was asked to meet on November 29, 2010, to review applications and interview candidates. All candidates were asked to complete an application and submit it to the Agriculture office by November 19, 2010. Due to the current two incumbents being the only applicants, Mr. Ron Mansfield, Fruit & Nut Farming Industry and Mr. Chuck Bacchi, Livestock Industry the review panel process was not necessary.

It is my recommendation to the Board of Supervisors to re-appoint Mr. Ron Mansfield to represent the Fruits and Nut Farming Industry and re-appoint Mr. Chuck Bacchi to represent the Livestock Industry on the El Dorado County Agricultural Commission for a four (4) year term beginning January, 2011.

Following Board action, the Agricultural Commission appointees, Mr. Ron Mansfield and Mr. Chuck Bacchi, will begin their terms January 2011 through December 2014 at the regularly scheduled Agricultural Commission meeting of January 12, 2011.
