- 2) There is no <u>written policy</u> it has been our practice in the past, as a courtesy, asked for a <u>recommendation</u> from the Board of Supervisors. However TRPA could, according to the Compact, appoint someone from the community ourselves and not ask for a <u>recommendation</u> from the Board of Supervisors
