RECITALS

WHEREAS, the parties hereto desire to amend the Agreement to add verbiage and an Exhibit pertaining to SB 1439, the Levine Act, which was passed by the voters and goes into effect on January 1, 2023; hereby amending ARTICLE XXI – Conflict of Interest;

NOW THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this Second Amendment to Agreement #6304 on the following terms and conditions:

I. ARTICLE III, Compensation for Services, Paragraph Three is amended to read as follows:

Total amount of this Agreement shall not exceed \$217,224.00, inclusive of all costs, taxes, and expenses.

II. ARTICLE XXI, Conflict of Interest, is amended to add Paragraph Four as follows:

Pursuant to Government Code section 84308 (SB 1439, the Levine Act), Consultant shall complete and sign the attached Exhibit B, marked "California Levine Act Statement," incorporated herein and made by reference a part hereof, regarding campaign contributions by Consultant, if any, to any officer of County.

Except as herein amended, all other parts and sections of that Agreement #6304 shall remain unchanged and in full force and effect.

California Levine Act Statement

California Government Code Section 84308, commonly referred to as the "Levine Act," prohibits any Member of the Board of Supervisor(s) of El Dorado County from participating in any action related to a contract if he or she receives any political contributions totaling more than two hundred and fifty dollars (\$250) within the previous twelve (12) months, and for three (3) months following the date a final decision concerning the contract has been made, from the person or company awarded the contract.
