Subject: Resolution Confirming Assessments in Zones of Benefit within County Service Area No. 10 for fiscal year 2023/2024

Attached for your review and approval is the above referenced Resolution.

The Resolutions for County Service Area No. 10 is being submitted to fulfill the requirements of Government Code Section 25210.77a which provides, in part, that (1) the Board of Supervisors may fix and collect charges for a particular county service; (2) the Board of Supervisors may have the charges collected on the tax roll, in the same manner and together with the general taxes; (3) an annual written report shall be prepared containing a description of each parcel of real property receiving the services and the amount charged per parcel in conformity with the ordinance authorizing collection of such charges on the tax roll; and (4) a public hearing shall be set to accept public comments related to the report prior to adoption of the Resolution fixing the rates.

Exhibit A to each Resolution includes a Summary of Direct Charge Levies. The summary information is based on the direct charge levies accepted for the previous tax year. The parcel list of each zone of benefit containing the detailed information required in the written report is not attached, at Counsel's request in previous years. The Direct Charge Levies Summary and Direct Charge Report for the County Service Area Zones of Benefit referenced in the Resolution will be attached to each staff report in Legistar.

The proposed assessments are a continuation of existing benefit assessments and represent no increase over the fiscal year 2022/2023 assessment amounts. The continued assessments are not subject to a vote under the County Charter. Your office has previously determined that these assessments are exempt from the procedures and approval process of Article XIII D of the California Constitution under Section 5(a) of the Article.

The Resolution for County Service Area No. 10 Waste Management Charges was prepared by the Environmental Management staff.

Hearings for the County Service Areas benefit assessments and fees are scheduled for the June 20, 2023 Board of Supervisors meeting. Public Notice of the hearing will be scheduled to appear twice in each of three local newspapers **between May 26, 2023, and June 2, 2023.**

Environmental Management Department and The Department of Transportation desire to have all of the hearings for CSAs 2, 3, 9, and 10 conducted concurrently. Drafts of the Public Notice are included for your review and direction regarding concurrent proceedings.

Approval by **May 22, 2023** will allow staff to meet submission deadlines for publication and the Hearing.
