FIRST AMENDMENT TO AGREEMENT FOR SERVICES #4527

RECITALS

WHEREAS, EBIX has been engaged by Client to establish and maintain all systems and programs necessary to maintain an accurate and up-to-date database of information concerning insurance information for Client's accounts for the Client's Risk Management Division pursuant to Agreement for Services #4527, dated December 31, 2019, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to update the Client's contact information on Page 20 of Exhibit D;

WHEREAS, the parties hereto desire to amend the Agreement to add Section A-2.6 to Exhibit D to state Client's Contract Administrator;

WHEREAS, the parties hereto desire to amend the Agreement to add Section B-1.5 to Exhibit D to clarify the not-to-exceed compensation amount of the Agreement, which is increased by \$39,419, for an updated not-to-exceed amount of \$75,819;

WHEREAS, the parties hereto desire to amend the Agreement to add Section B-2.6 to Exhibit D to specify the Client's Invoice Address;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, Client and EBIX mutually agree to amend the terms of the Agreement in this First Amendment to Agreement for Services #4527 on the following terms and conditions:

- I. The following Sections of the Agreement are added to read as follows:
 - A-2.6. The County Officer or employee with responsibility for administering this Agreement is Joseph Carruesco, Director, Human Resources Department, or successor.
 - **B-1.5.** The total amount of this Agreement, as amended, shall not exceed \$75,819 inclusive of all costs, taxes, and expenses.

B-2.6. Itemized invoices shall follow the format specified by Client and shall reference this Agreement number on their faces. Copies of documentation attached to invoices shall reflect EBIX's charges for the specific services billed on those invoices. Invoices shall be mailed to Client at the following address:
