Topic: SB1383 Solution – Contract Follow Up

Good Morning Governing Board,

Staff sent out the negotiated contract template to all member agencies that were interested last week. Staff has received some inquiries on understanding the pricing exhibit (Schedule 1) and the different tiers referenced. The purpose of this email is to help our member agencies prepare the contract for adoption and/or assist in the decision process. Except for Rocklin, all our member agencies are either moving forward with this alternative or are still in the decision phase. The intent of this note is not to pressure any member agency to join this effort but only to provide clarification.

The contract references various tiers of pricing based on attributes commissioned. If neither El Dorado nor Placer County join, the remaining member agencies would fall under Tier 1 pricing. If one of the counties joins, then Tier 2 pricing would apply to all member agencies and if both counties join, Tier 3 pricing would then apply. Member agencies will not be paying different rates based on when they join but the tier rate will apply to all member agencies. The table below illustrates the pricing by tiers:
