After much internal discussion, Waste Connections can make a commitment to bringing the ~2,100 tons of compost to EDC by years end. Our issue is twofold; first, as the year ticks on we are losing days to bring this material. We anticipate 4-5 trucks a week from August to years end to get us to our 30% goal. Secondly, we would need to start advertising formally to farmers, site checking locations, and getting commitments and scheduling. This is already a monumental task, but we are prepared to start, assuming the County looks to be interested. Having a public pickup site or two would help offset problems with scheduling, weather issues and other shipping related issues.

We are starting a pilot program next week with anticipation to bring beautiful compost to a vineyard for application. The feedback we get will help us demonstrate concept and hopefully get farmer buy in.

I also have hope that excess compost can be utilized in forest land or by public works. In the summer and winter, we can anticipate a decrease in compost request from farms and rehabbing public lands could be a great option to keep a consistent flow of compost moving year-round.
