**RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION
PROGRAMMING LOCAL BICYCLE AND PEDESTRIAN FUNDS TO MATCH THE EL DORADO
COUNTY DEPARTMENT OF TRANSPORTATION STATE SAFE ROUTES TO SCHOOL
APPLICATION FOR PHASE II OF THE NORTHSIDE SCHOOL BIKE PATH PROJECT**

WHEREAS, pursuant to California Government Code, Title 7.91, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the area of El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, California Government Code Section 29532.1(g) identifies EDCTC as the designated regional transportation planning agency for El Dorado County, exclusive of the Lake Tahoe Basin; and is responsible for the planning, allocating and/or programming of funds; and

WHEREAS, EDCTC is responsible for the administration of Transportation Development Act Funds; and

WHEREAS, EDCTC has accumulated unprogrammed Transportation Development Act Article 3 Funds available for Bicycle and Pedestrian projects; and


WHEREAS, in accordance with TDA Statute 99234(a), EDCTC has adopted programming guidelines for use of local bicycle and pedestrian funds; and

WHEREAS, the El Dorado County Department of Transportation submitted a Cycle 8 State Safe Routes to School application for construction of Phase II of the Northside School Bike Path project; and


NOW THEREFORE, BE IT RESOLVED, that EDCTC has approved the programming of \$140,000 in local bicycle and pedestrian funds to the El Dorado County Department of Transportation to match the Cycle 8 State Safe Routes to School grant application for Phase II of the Northside School Bike Path project.
