In the current proposed budget, the funding request from the Shingle Springs/Cameron Park (SS/CP) Chamber has been deferred due to lower than expected TOT Funds. Yet, the current budget has tentatively approved a <u>significant</u> increase, by \$225,000 TOT funding that would only benefit two similar Chambers on the west slope.

Considering that the SS/CP Chamber is:

- 1. Similar in providing visitors with travel information leveraging its visitor signage on Highway 50,
- 2. An asset to the County as a growing economic driver, having grown its membership by 25% year over year, and
- 3. Within the SS/CP area which generates TOT funds from its hotels/motels and AirBNB's, it deserves to have its request for a modest \$35,700 approved.

One option to find funding, would be to simply hold the current benefiting Chambers at the same funding level as last year. This would free up more than enough funds, while treating similar Chambers fairly.

We, respectfully, ask the Board to reconsider and find a way to keep their previous intent to provide funds to the SS/CP Chamber.

Cameron Park and Shingle Springs, as a region, has been working towards responsible economic growth and developing the region as a viable community to invest in both financially and personally.

Our chamber has grown its membership by an astonishing 25% in a very short period of time and continues to attract new members on a weekly basis. They work tirelessly and collaboratively with the community on special events to drive interest to the area and have done an excellent job on execution. The Board should encourage this practice by distributing these funds more equitably and approving their modest request.
