FIFTH AMENDMENT TO AGREEMENT TO MAKE SUBDIVISION IMPROVEMENTS FOR CLASS 1 SUBDIVISION BETWEEN COUNTY AND OWNER

RECITALS

WHEREAS, County, and Owner entered into that certain Subdivision Improvements Agreement on November 14, 2017, entered into the First Amendment to Agreement on November 26, 2019, the Second Amendment to Agreement on October 13, 2020, the Third Amendment to Agreement on November 4, 2021, and the Fourth Amendment to Agreement on November 2, 2022, in connection with the Subdivision, copy of which Agreement is incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

 - 3. Complete the Subdivision improvements contemplated under this Agreement on or before November 14, 2024.

Except as herein amended, all other parts and sections of that certain Agreement dated November 14, 2017, shall remain unchanged and in full force and effect.
