CHAPTER 9.47. SKATEPARKS

Sec. 9.47.010. Title.

This chapter shall be known as the County Skatepark and Bike Park Ordinance.

Sec. 9.47.020. Purpose.

- A. The purpose of this chapter is to promote the public peace and the health, safety, and welfare of residents of the County by establishing regulations for the use of skate_parks_and bike parks_owned or operated by the County. This chapter does not preclude other civil or criminal actions in regard to conduct proscribed herein.
- B. The County Board of Supervisors hereby declares that skateboarding <u>and bicycling</u> is a hazardous recreational activity <u>pursuant to California Government Code section 831.7</u>. Individuals using a skate <u>or bike</u> park owned or operated by the County shall assume all risk of injury or loss.

Sec. 9.47.030. Safety equipment.

Any person entering, using, or remaining in a skate or bike park owned or operated by the County shall wear proper safety equipment for skating or for bicycling, including, but not limited to, a secure helmet, knee pads, and elbow pads. All safety equipment shall be functional, properly sized, and in good repair. Helmets shall conform to State standards relating to bicycle safety helmets.

Sec. 9.47.040. Regulations.

<u>For purposes of this section, the term "park" refers to any skate park or bike park owned or operated by the</u> <u>County.</u> All persons entering, using, or remaining in <u>the park any skatepark owned or operated by the County</u> shall comply with the following rules and regulations:

- A. The skatepark shall have fixed hours of use, which shall be posted at the skatepark. No person shall use the skatepark at times other than those posted at the skatepark. Hours are subject to change. The County may close the skatepark whenever it determines that such closure is necessary, such as during the County Fair, special events, inclement weather or following vandalism, graffiti, or a gross violations of the rules and regulations. The skatepark shall be closed during the County Fair and during other special events. In addition to other penalties specified herein, use of the skatepark after posted hours or during a time of closure may result in a trespassing citation and denial of future use of the skatepark.
- B. The skatepark may be used by skateboarders on the days designated for that particular use and only in accordance with the schedule of use, which shall be posted at the skatepark.

- C. All persons entering, using, or remaining in any skatepark must wear a shirt and applicable safety equipment while on skatepark property.
- D. No person may bring structures, obstacles, or other materials, such as ramps or jumps, into the skatepark.
- E. Smoking, tobacco, drugs, and alcoholic beverages are prohibited anywhere at or near the skatepark.
- F. It shall be unlawful to engage in graffiti, tagging, or other defacing (such as the placing of stickers or decals) onf skatepark property or the property of others, as more specifically proscribed in Chapter 9.50.
- G. Except for authorized guide dogs and service animals, animals are prohibited in the skatepark.
- H. Glass containers are prohibited anywhere at or near the skatepark.
- I. Recklessness, horseplay, foul language, vandalism, and disrespect to staff and/or other skatepark users is prohibited.
- J. No person shall skate <u>or bicycle</u> on curbs, fences, railings, walls, benches, tables, and/or driveways of the County-owned area surrounding the <u>skatepP</u>ark. <u>SkatepP</u>ark users shall be considerate of nearby businesses and residents in the surrounding neighborhood.
- K. No skating or bicycling is allowed at the skatepark when the skatepark surfaces are wet.
- L. All injuries, whether major or minor, suffered at the skatepark are to be reported to County.-Parks and Recreation Staff at (530) 621-5330.
- M. The County shall not be responsible for any personal belongings lost or stolen at the skatepark.
- N. Amplified music and sound systems are prohibited at the skatepark-unless prior written authorization for use of amplified sound for special events is obtained from the parks and recreation manager or designee.
- O. Climbing on or over the skatepark fence is prohibited.
- P. No motorized vehicles, including remote control cars and electric bicycles, are allowed at the park.
- Q. No barbecues or open flames are allowed at the park.
- R. No digging of soil or vegetation, changing trails, or riding off trail is allowed at the park.

Sec. 9.47.050. Enforcement.

- A. Any violation of these rules and regulations will result in immediate expulsion from the skatepark and County Fairgrounds property (if applicable). Three violations within a consecutive 12-month period shall result in a suspension of use of the park for up to one year. a one-year expulsion from the skatepark.
- B. Any person who violates any of these rules and regulations shall, in the discretion of the enforcing authority, be guilty of an infraction or a misdemeanor and, pursuant to Chapter 1.24, may be subject to punishment according to the general penalties described in Chapter 1.24. Violation of the provisions of this chapter shall, in the discretion of the enforcing authority, be deemed an infraction or a misdemeanor and, pursuant to Chapter 1.24, may be subject to punishment according to the general penalties to punishment according to the general penalties described in Chapter 1.24. - C. In addition to authorized law enforcement agencies, County parks and recreation staff shall have authority to enforce <u>this chapter</u>these rules and regulations, issue <u>administrative</u> citations for violations of these

provisions of this chapter rules and regulations, and confiscate personal property which are being used or operated in violation of the provisions of this chapter.as provided herein.

D. Any person who is adversely affected by an enforcement action or issuance of an administrative citation from County parks and recreation staff may appeal said action or citation within ten (10) business days of the enforcement action or citation date by filing a written appeal with the Chief Administrative Office. An appeal hearing will be scheduled within ten (10) business days of the filing of the written appeal. A written decision on the appeal will be issued within ten (10) business days of the hearing. The decision of the Chief Administrative Office shall be final.

Sec. 9.47.060. Notice.

A sign or signs shall be posted at all skatepark facilities providing notice that the violation of the skatepark's rules and regulations shall subject the violator to the penalties described in Section 9.47.050.

Sec. 9.47.070. Negligence per se.

Any person who fails or refuses to comply with the provisions of this chapter and who is injured while using the skatepark shall be deemed negligent per se.
