Dear Ms. Dutschke,

The County of El Dorado has received a Notice of Non-Gaming Land Acquisition Application (“Notice”) seeking acceptance of title to real property “in trust” by the United States of America for the Shingle Springs Band of Miwok Indians, Shingle Springs Rancheria (Verona Tract), California.

The Notice indicates the County has 30 days to submit written comments on the proposed acquisition. On behalf of the County of El Dorado, our Board of Supervisors respectfully submits to you our request to extend the comment period by an additional 30 days.

The Notice for Case #40317 includes 10 parcels, representing approximately 81.7 acres of land for the County to evaluate. The Notice for Case #40447 includes 11 parcels, representing approximately 107.3 acres of land for the County to evaluate. An extension of the comment period will allow our County, in coordination with the appropriate County Departments, to review and thoroughly assess the impact of the removal of the identified properties from the tax roll, the impact to services that are currently provided to the properties, and an analysis of how the intended use is consistent or inconsistent with current zoning. This coordination with County Departments and the fact that the Board of Supervisors is dark for the last two weeks in November require additional time for the County to provide meaningful comments that are authorized by the Board.
