Honorable members of the Board of Supervisors,

This written comment is to state that it is clear to me that the intent of staff is that the park is being designed as a more regional sports complex, and not the community park that it has been advertised as. The Parks manager has stated publicly that it would be wonderful if we could have tournaments that would attract teams from around the region that would stay in our motels, eat at our restaurants, and utilize our services. This potential is addressed within the EIR. This does not sound like a community park; it sounds like a regional sports complex.

It is clear that the real intent of this project is for a regional sports complex as is evident from public statements of staff, and the project plan as designed, the rejection of the lower density alternative, and the failure to even produce a plan for the road connector alternative. Further evidence is the final EIR's dismissive rejection of this alternative in the documents narrative.

If the project is for a regional sports complex, then the project no longer meets the criteria for a community park and the entire VMT analysis becomes invalid, and the project potentially violates the CEQA VMT thresholds.

Because of this it is requested that the final EIR not be certified, and the project as presented not be approved but be sent back to staff for redesign, and reevaluation.

The creation of this community park will have the effect of inducing demand amongst park users that would prefer to either walk to the park or ride bicycles. The park project must mitigate for this induced demand by providing CL II bike lanes and sidewalks on Pleasant Valley Rd. between Patterson Dr. and Koki Lane, and on Oak Dell Rd. These facilities would appear to be mandated under Policies TC-4i and TC-5c of the General plan, and yet they have not been addressed in the EIR

The Alternatives analysis done under section 4 of the EIR was entirely deficient with respect to accommodating the Community Traffic Circulation (CTC) plan. It appears that staff and consultants were purposely dismissive of this alternative, and seemed to ignore the fact that the approval action taken by the Board of Supervisors specifically included the requirement that community road circulation be incorporated into the project description. What has not changed is the need for the CTC plan south of Pleasant Valley Rd., and the need to connect Oak Dell Rd. into that system.

Rather than design a road though the park that would connect to the circulation system south of the park, it would appear that the consultants and county staff merely overlayed the originally proposed street system over the proposed park plan and dismissively concluded that "Gee" it won't work because it impacts too much of the park, and it will impact natural and cultural resources.

Whether that was an intentional approach or not, it renders the EIR fatally flawed. Contrary to Board of Supervisors direction, County staff and consultants are proposing to completely block off this linkage to the CTC plan rather than working to maintain this parcel as a part of the comprehensive circulation network that will allow for residents of Diamond Springs and El Dorado the ability to access the park, and the schools without having to add to the traffic congestion on Pleasant Valley Rd.
