

NOTICE OF A PUBLIC HEARING

To consider the Resolution Adopting the Bass Lake Hills Specific Plan Public Facility Financing Plan 2024 Annual Fee Schedule

NOTICE IS HEREBY GIVEN that on February 27, 2024, at 1:15 p.m., or as soon thereafter as the matter can be heard, the County of El Dorado Board of Supervisors will hold a public hearing to receive oral and written testimony regarding the adoption of the proposed resolution revising the area-specific fees for development within the Bass Lake Hills Specific Plan Area. The proposed fee will be collected from developers upon the issuance of a building permit within the Plan Area. Interested parties are invited to write their comments in support or opposition to the Resolution to the Board of Supervisors in advance of the hearing. In light of COVID-19, all persons may be required to observe and participate in the hearing remotely as in-person attendance may be restricted depending on the current COVID-19 recommendations as the hearing date approaches. For the current remote options, please check the meeting Agenda, which will be posted at <https://eldorado.legistar.com/Calendar.aspx>, no less than 72 hours before the meeting. Any written correspondence should be directed to the Board of Supervisors, 330 Fair Lane, Placerville, CA 95667. At least ten (10) days prior to the public hearing, a copy of the proposed resolution and data required by Government Code section 66016 indicating the amount of cost, or estimated cost, required to provide the services for which the fees will be levied and the revenue sources anticipated to provide the services will be available for public review with the Clerk of the Board of Supervisors at the following address: 330 Fair Lane, Placerville, California 95667 or online at <https://www.edcgov.us/Government/DOT>.
