## A. The good/service requested is restricted to one supplier for the reason stated below:

1. Why is the acquisition restricted to this goods/services supplier? (Explain why the acquisition cannot be competitively sourced. Explain how the supplier is the only source for the acquisition.)

This request is a renewal for existing established and approved services and licenses. While Crowdstrike Falcon is available through resellers, we have been partnering directly with Crowdstrike to procure licenses and Falcon Complete security services since 2020. The direct procurement of licenses allows for better pricing than the State's competitively bid contract for CrowdStrike Falcon Complete through resellers; therefore competitive bidding would produce no economic benefit to the County.

2. Provide the background of events leading to this acquisition.

IT first contracted directly with Crowdstrike in 2020 for Enterprise Virus Protection. While there are resellers of Crowdstrike products, changing our licenses to a third-party provider causes disruptions to the security and network/server teams, along with providing no economic benefit to the County.

3. Describe the uniqueness of the acquisition. (Why was the goods/services supplier chosen?)

Crowdstrike offers El Dorado County IT has historically provided better pricing discounts to the County compared to the State's competitively bid contract for Crowdstrike Falcon Complete.

4. What are the consequences of not purchasing the goods/services or contracting with the proposed supplier?

Loss of efficiency, continuity, and loss of staff time to change vendors. Moving to a third-party reseller causes disruptions to the security and network/server teams, along with providing no economic benefit to the County. Crowdstrike continues to provide El Dorado County deep discounts over List and NASPO pricing.

Changing vendors would require the removal of 2300 end-point agents and their re-installation. It would not only be resource intensive to deploy, it would take months to implement with a new vendor.

5. What market research was conducted to substantiate no competition, including the evaluation of other items or service providers? Crowdstrike is a vital component to the County's infrastructure. Purchasing services and coverage directly from Crowdstrike provides us with the best pricing and service.

The Crowdstrike Cyber Security solution is based on its unmatched performance, advanced threat detection capabilities, and seamless integration within our existing infrastructure. Crowdstrike has consistently demonstrated superior efficiency in identifying and mitigating evolving cyber threats, ensuring the highest level of protection for our assets.

### B. Price Analysis:

1. How was the price offered determined to be fair and reasonable? (Explain what basis was used for comparison and include cost analysis as applicable.)

Crowdstrike List Price for services totals \$470,074.96. NASPO Pricing for services under AR2472 totals \$411,261.66 Crowdstrike is offering a 1-year renewal for \$155,878.90, which is a savings of over \$255,000.

2. Describe any cost savings or avoidance realized (one-time or ongoing) by acquiring the goods/services from this supplier.

In addition to price savings as noted in B.1., staying with Crowdstrike saves staff time and labor costs in not having to reestablish critical services through a reseller.

Transitioning to an alternative solution would entail significant costs, both in terms of financial investment, internal resources, and significant disruption to our operations.
