Dear Supervisors,

You should reject the application for PA23-0015/Community Health and Independence as a proposal antithetical to the values of residents and their health that it purports to enhance. The proposal violates the SACOG Blueprint that calls for development near existing centers and utilizing infill development to meet our growth goals. This proposal is sprawl on the edge of the urban area that will reduce residents' health by adding VMT, reducing air and water quality, requiring expensive new infrastructure. Approving developments such as this one will guarantee the region does not meet mandated VMT reductions and jeopardize funding for transportation regionwide.

Valley Vision's Livability Poll shows that residents place the highest value in our region on our natural spaces, and the Nearby Nature south of El Dorado Hills will be destroyed by this development. This is agricultural grazing land, and in the 30 years prior to 2018 the region lost 273,000 acres of farmland - an area larger than twice the size of Lake Tahoe.

There is nothing healthy about this kind of development. It leads to increased driving, traffic, air pollution, isolation, and sedentary lifestyles. UC Davis Health should be ashamed of having their name associated with such a proposal.

Further, AKT has a history of using Trojan horses such as universities that they use to get entitlements and then fail to deliver the promised amenities. If they truly wanted to create a community for healthy aging they could use their substantial resources to locate facilities in existing communities that need investment.

In addition to what a bad example of planning this would be if you approve it, there is no water source identified and this project would require resources that could be better put to use by investing in the existing communities of El Dorado County and the region.

Cut down the oak trees and fill the freeways with traffic - that's the promise of this proposal. Please reject it.
