AGREEMENT FOR SERVICES #216-S0911 AMENDMENT II

This Amendment II to that Agreement for Services #216-S0911, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Legalese Attorney Service, a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 1754 36th Street, Sacramento, California 95816; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County for to provide service of process on an "as requested" basis for Departments County wide, in accordance with Agreement for Services #216-S0911, dated September 16, 2008 and Amendment I, dated September 15, 2009, both incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to expand the scope of services, hereby amending ARTICLE I – Scope of Services and ARTICLE III – Compensation for Services; and

WHEREAS, the parties hereto have mutually agreed to extend the Agreement for one additional year, hereby amending ARTICLE II – Term.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #216-S0911 shall be amended a Second time as follows:

ARTICLE I

Scope of Services: Contractor agrees to furnish materials and personnel, necessary to provide service of process on an "as requested" basis for Departments County-wide. Services shall include, but not be limited to, those set forth in amended Exhibit "A", marked "Scope of Services and Rates", incorporated herein and made by reference a part hereof.

ARTICLE II

Term: This Agreement shall become effective upon final execution by both parties hereto and shall cover the period of September 16, 2008 through September 15, 2012.

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Contractor within thirty (30) days following completion of work and the County's receipt and approval of itemized invoice(s) identifying services rendered. For the purposes herein, the billing rates shall be in accordance with amended Exhibit "A". The total amount of this Agreement shall not exceed \$200,000.00 for the three (3) year period.

Except as herein amended, all other parts and sections of that Agreement for Services #216-S0911 shall remain unchanged and in full force and effect.
