Frank,

Listed below is an accurate depiction of what occurred yesterday when I went to drop off the bid at EID orado County.

I arrved at the delver address spelled out in the RFP at 1:30 PM. I spoke to Judy at the front counter and informed her that I had a bid package to drop off for the access control and CCTV project and showed her the envelope which she helped me tape. I asked Judy if this is where I dropped off the bid package and she said yes. At that point she input me into their system letting Sherry know that I was there to drop off a bid package. She asked me to take a seat and as soon as Sherry was avallable she would have me go back to see her. At ten minute till 2:00 PM I informed Judy again her that the bid was due no later then $2: 00 \mathrm{PM}$ and I needed to hand it over to someone before hand. I asked if she was sure that only Sherry could take it Judy said yes because Shirley was out to lunch still, however I was input in the system as checking in at 1:35 PM so I should have no problem. She then wrote a note to Sherry on blue scratch
paper to let her know that I was there to drop of a bid package and was concerned about the time. She went into the back and handed to her. Judy then came back to inform me that she would still take me after 2:00 PM. At 2:04 pm Shirley came back from lunch and said that she would see me. I went to hand her the bid package and she said that I could not hand it to her and that I needed to go to building A and hand it to the Clerk of the board there. I mentioned there was no Building specified in the bidding documents and building A, B and C all had the same address. I then ran over to the Building A (1 arrived at Building A after 2 PM ) and found the Clerk of the boards reception desk. At which time he had no idea what I was talking about when I asked if this is where I turned the bid package in. There were no other clerks desks only hearing rooms. He advised me to go back to building C which I came from and try upstairs. I ran back to building C and ran upstairs and spoke to Pam who said I was not in the right location and needed to run back to Building $A$. I said I just came from $A$ and at this point it was 2:12 PM. She asked if I arrived at Building A after 2:00 PM. I said yes because I was told to drop off the package to Sherry or Shirley downstairs. She said The people were waiting in a hallway of building A to take the packages and at 2:00 PM they left. There was nothing she could do.

I said that I am in their system and on site at 1:35 PM to drop off this bid package. Pam tried to call a couple of people and then went into Janel's office. She came out and said she could do nothing. I asked if there was anyone that I could talk to and this was not right, that I was sent on a wild goose chase for 45 mins. I then told her that I was in so much trouble with my boss. She handed me a card with Janel's phone number written on the back and told me to have my boss talk to Janel.

I notified the office of the misunderstanding of the run around I received and left the site at 2:28 PM with the bid package in hand very upset.

No where in the bid package does it state which building I need to drop off the bid package: the cover, Page $\mathrm{N}-1$, page IB-2, Page IB-3 all show the address without the building number.
